**Re:** TPO Project Priority List

**Issue:** The North Florida Transportation Planning Organization (TPO) is requesting Clay County submit its project priority list for 2018.

**Project Priority List:** Each year the North Florida TPO requests that each County and municipality submit an updated list of priority projects. The list of priority projects identifies potential projects to be funded in the new fifth year of the FDOT Work Program. However, by creating the Strategic Intermodal System (SIS) and the Transportation Regional Incentive Program (TRIP) in Florida, the *"List of Priority Projects"* now includes potential projects to be funded in other years of the FDOT Work Program under the SIS and TRIP programs." The list of priority projects adopted by the County Commission at its meeting of April 11<sup>th</sup> last year is as follows:

Staff notes that of the projects submitted last year, the TPO's list of Priority Projects has C.R. 220 from S.R. 21 to Knight Boxx Road as priority #4 in the list of Region-Wide projects. The construction phase of C.R. 220 between Knight Boxx Road and Henley Road is included in the FDOT 5-year Work

program at a cost of \$12,720,495 in FY 2020/21. C.R. 218 from Astor/Pine Tree to Cosmos Avenue is priority #18 in the list. FDOT projects on U.S. 17, S.R. 16, and S.R. 21 are also included in the list and staff proposes no change to their status.

**Recommended Changes From Last Year:** Staff recommends that the same list be submitted this year, with one addition. Staff requests that the list be amended to add necessary intersection improvements at C.R. 220 and U.S. 17 as Priority #5. The increase in traffic volumes at this intersection causes extensive queueing during the peak hour.

**Transportation Alternative Program Projects:** The Transportation Alternatives Program (TAP) provides funding for programs and projects consistent with details described under 23 U.S.C. 133(h)(3), including on- and off-road pedestrian and bicycle facilities, infrastructure projects for improving non-driver access to public transportation and enhanced mobility, community improvement activities, and environmental mitigation; recreational trail program projects and safe routes to school projects.
