Vice-Chairman Mike Cella stated the request to pull item 7 was to get some questions answered and bring it back for consideration on the April 23, 2024, BCC meeting.

#### DISCUSSION/UPDATES

15. Progress Report on the Bonded Transportation Program (E. Dendor)

Ed Dendor, Program Administrator of the Bonded Transportation Program, addressed the Board to give a brief overview of the progress report attached to the agenda for the BTP on the following projects:

- Project #1 CR 218 from Masters Rd to Pine Tree Lane: On March 19, 2024, CCUA's Board met and approved the inclusion of their work with the County's award of RFB 23/24-25. Subsequent to the notice, the county forwarded a draft agreement to Anderson Columbia Co., Inc. for review and execution. On March 27, 2024, the team held a preconstruction meeting with the utilities to kick start their relocation. Visual sign boards were placed notifying the traveling public of the construction start date.
- <u>CMAR Group #2 Projects #2, #5 and #6A:</u> Appraisals and offers continue for ponds sites and ROW acquisitions. Some ROW acquisitions continued to be pursued through the Eminent Domain proceedings. The team continued to evaluate the impacts of the US District Courts opinion of the FDEP 404 wetland permits and the team is developing options to try and progress the CMAR#2 projects.
  - Project #2 (CR209): Superior finished the clearing and grubbing work on the pond site west of the railroad track and continued with clearing along the right of way on CR209. On the eastside of the railroad track Superior placed silt fence along the right of way and continued the clearing and grubbing efforts at the pond site east of the railroad track. Utility adjustments continued throughout the corridor.
  - Project #5 (CR220): The FDEP 404 permit delay will impact this project due to the Federal injunction ruling. Final sign and sealing of this plan set is delayed. Once the federal and state permit issues are resolved the project will be packaged up and delivered to the County's Engineering Department for future phased construction.
  - **Project #6A (CR315):** ROW acquisition efforts continued while some of the

properties are being pursued through Eminent Domain proceedings. Comments were provided to Jacobs on the 100% plan set. Jacobs is responding to the comments and updating the plans. Final plans will be accepted when all comments are addressed. The plan set will be shelved for phased construction at a later date. The team is considering a slimmed down version of the operational and signaling improvements due to the federal injunction on the FDEP 404 permit. The team is working with Superior for a GMP. These "on the fly" changes due to the permit injunction will also affect how project 6A and 6B roadway tie together. Various options are under consideration. The team submitted a permit application through the Army Corps of Engineers in attempts to keep the permit effort moving forward, somewhat of a dual or duplicated process.

- **CMAR Group #1 Projects #3 and #4:** Bi-monthly status meetings were held.
  - Project #3A (CR209 AKA Russell Rd): The contractor, Kirby Development, for the CR209 section from just north of Oak Stream Road to just south of Watkins Road continued with the operational and safety improvements.
  - **Project #3B (Connecting the east-end of project #4 and runs through** <u>the roundabout to CR 209B</u>): Kiewit continued their pre-mobilization activities. The county issued Kiewit's first Notice to Proceed along with a Purchase Order. The team continued working with multiple property owners to obtain the necessary right-of-way for the balance of the roadway realignment.
  - Project #4 (CR739B AKA Sandridge Road): Kiewit continues construction activities along both side and across Sandridge Road with stormwater drainpipe, and road construction. 100% of the drainage structures are now in place with approximately 90% of the drainage pipe installed. This project is on schedule with 48% paid and 49% of time has been used.
- Project #6B (AKA Cathedral Oak Parkway (COP & CR216), FKA the First Coast Connector): The County's Team and Superior Construction Company Southeast, LLC (SCC) and their designer RS&H continued to hold bi-monthly status meetings. Cut and fill operations continues throughout the roadway corridor from SR23 at the far west-end of this project to CR 315 and Maryland Avenue at the far east end. Pile caps installation continued at the bridge while Superior continued setting beams on the completed pile caps. Stormwater cross drainpipe installations continue to be placed along with sub-base, limestone, sidewalk, and curbing installation continued from west to east.

Mr. Dendor noted that as the team has six projects underway in the field and approaching 300,000 man hours of work with zero reported incidents. He thanked the support staff and team for all their hardwork and the community for helping keep everyone safe.

Following all discussions, the Board agreed to move forward with the request, as discussed, to bring back the request separately.







COMP 24-0005 Public Hearing April 9, 2024

#### **APPLICATION INFORMATION**

County initiated text amendment to the Comprehensive Plan in response to requirements of HB 1379 (protection of environmental resources).

PC Hearing April 2, 2024, voted 6-0 to recommend approval to transmit

#### BACKGROUND

- Basin Management Action Plan (BMAP) for the Lower St. Johns River Basin (LSJR), is one piece of a statewide effort to restore and protect Florida's Water Quality. It established Total Maximum Daily Loads (TMDLs) for impaired waterways.
- "A TMDL is the maximum amount of a specific pollutant that a waterbody can assimilate while maintaining its designated uses." (Oct. 2008, BMAP)
- DEP has identified segments of waterways in LSJR and adopted TMDLs for Total Nitrogen and Total Phosphorus
- BMAP identified strategies to reduce nutrient discharge in basin (structural and nonstructural)
  - Wastewater treatment plant upgrades
  - Reuse of wastewater for irrigation and other uses
  - Stormwater retrofits
  - Urban structural Best Management Practices
  - Urban nonstructural Best Management Practices (cleaning/maintenance activities)
  - Agricultural Best Management Practices
  - Environmental education, and
  - Water quality credit trading.

#### BACKGROUND

- To further strengthen these efforts, HB 1379 requires Comp Plans to be amended (by July 1, 2024) to include a list of projects that are necessary to achieve pollutant reductions as established in the BMAP.
- The bill further requires local governments to consider the feasibility of providing sanitary sewer services within a 10 year planning horizon for any development of more than 50 residential lots with more than one sewage treatment and disposal system per acre.



#### **PROPOSED AMENDMENTS**

An amendment to add a new policy to the Community Facilities Element -

• <u>CFE POLICY 1.4.8</u>

 The County shall coordinate with Clay County Utility Authority to assess the feasibility of providing sanitary sewer services, within a 10-year planning horizon, for any development under its jurisdiction of 50 or more residential lots, whether built or unbuilt, with more than one onsite sewage treatment and disposal system (OSTDS) per 1 acre. This analysis shall be conducted pursuant to Section 163.3177 6(c)3 of the Florida Statutes, incorporated by reference in this element by July 1, 2024, and updated as needed thereafter to account for future applicable developments.

#### PROPOSED AMENDMENTS

An amendment to add a new policy to the Capital Improvements Element -

• <u>CIE POLICY 1.4.5</u>

 The County shall annually update as necessary into its Capital Improvement Element a schedule of capital improvements which may include any publicly, funded projects of federal, state, or local government, and which may include privately funded projects for which the local government has no fiscal responsibility that provide for increased capacity or upgrade of treatment required to achieve the pollutant load reductions attributable to the County, to meet the Total Maximum Daily Load (TMDL) established in the Lower St. Johns River basin management action plan pursuant to s. 403.067 (7). If the current TMDL is being met no projects shall be listed.

#### RECOMMENDATION

Staff recommends approval to transmit COMP 24-0005.
