Re:	Proposed Contract with Health Planning Council of Northeast Florida

Clay County qualifies as a CDBG-eligible County, which entitles the County to approximately \$800,000 a year in block grant funding from HUD. However, a number of specific tasks have to be completed in order for the County to procure this annual funding. These tasks are somewhat labor intensive and require a certain level of expertise; as such, staff believes it in the best interest of the County to contract with the consultant team to accomplish these tasks.

The attached contract for your consideration is with the Health Planning Council of Northeast Florida (Council). The Council has formed a top-notch consulting team that we believe are very capable in completing the necessary work in order to meet the HUD regulations. The consulting team's qualifications are included in the packet. Also included is a letter of recommendation from the Clay County Health Department that recognizes the abilities of the Council and its team to effectively address the requirements. Because the Council is recognized as a government agency, pursuant to State of Florida law no competitive bid process is necessary. In addition, the estimated cost of completion of the necessary steps to be taken is included in the CDBG funding; therefore, the County will be reimbursed for any costs incurred in completing the Consolidated Plan and the other requirements.

Recommendation: Staff recommends that the Board of County Commission approve this contract with the Health Planning Council of Northeast Florida.
