Pursuant to THE TAYLOR FAMILY REVOCABLE TRUST, DATED APRIL 26, 2007 (the "Trust"), created by CHARLES R. TAYLOR, SR. and MARILYN O. TAYLOR, residents of Clay County, Florida, as the "Trustors" therein, the undersigned CHARLES R. CHARLES R. TAYLOR, SR. and MARILYN O. TAYLOR were the original trustees under the Trust. CHARLES R. TAYLOR, SR., deceased on June 19, 2012, and MARILYN O. TAYLOR deceased on October 26, 2017. A copy of her certificate of death is attached hereto for recording purposes as Exhibit "A". CHARLES R. TAYLOR, JR. is designated as successor trustee in Article II.A.2. of the Trust

STATUTORY NOTICE TO ACCEPTING TRUSTEE:
