NOW THEREFORE, THE CONDITIONS OF THIS OBLIGATION ARE SUCH that if the Principal shall fully guarantee, indemnify and save harmless the Board of County Commissioners of Clay County and Clay County from all loss, cost, expenses and damages, for any repairs or replacements arising out of defective workmanship or materials in the construction or installation of said improvements, then this obligation shall be null and void; otherwise to be and remain in full force under the provisions Article IX of the Clay County Land Development Code as to any claims arising prior to its termination as provided within.
