#### **Middleburg Colored School Update:**

Dr. Maureen Jung addressed the Board to provide an update regarding the Middleburg Colored

School. The text is still under review, and the search for dates for the original closure of the school and the building of the Hunter Douglas School is in progress.

## Fort 11 Update:

Vice-Chairman Deirdre Murphy addressed the Board to provide information regarding the Fort 11 update. The Fort 11 marker has been temporarily set aside to focus more on Keystone Heights Marker. There are still questions regarding the exact location of the Fort.

#### **Keystone Heights Update:**

Vice-Chairman Deirdre Murphy addressed the Board to provide details and information regarding the Keystone Heights marker update. Vice-Chairman Murphy spoke about meeting with the City Council of KH and mentioned the information gathered for the marker, i.e., location, photos, and the need to present to the Council again due to unforeseen circumstances.
