Branan Field OLF:

Beth Carson, Director of Planning and Zoning, addressed the Board to provide details and information for the BF - OLF update. The State Council heard the item on August 19, 2025, and it was approved with minimal revisions. Production could take 7-8 months. Ms. Carson also provided an update on St. Mary's Episcopal Marker, and noted that staff mentioned that it could be next spring due to the back log.

Fort 11:

Billy Gould, Chairman, addressed the Board to open the floor for discussion on the status of the application and language regarding Fort 11.

There were questions, discussions, and clarifications regarding the application submitted, the text/language agreed on, the location of the Fort, and how to move forward.

Mr. Casale addressed the Board to provide details and information regarding the update for Fort 11, following a phone call taken just before the meeting to discuss the site/location of Fort 11.

Further discussion took place regarding a map that shows the location, and it can be tied to modern-day maps for a more precise location and application submission.

Middleburg Museum/Civic Center:

Gerard Casale addressed the Board to provide the details and information for the update regarding Middleburg Museum/Civic Center. Recently there was a decision to revisit the text/language for the marker and will take place Sunday.

There were questions and discussions regarding submitting the language timeline, back-up information for the language, and finalizing the information.

3. County Historic Signage Discussion

Chairman Billy Gould opened the floor to discuss the county historic signage. A replica of a county sign was displayed for reference during the discussion, along with the application and approval process.

There were questions and discussions regarding the design, size, inclusion of sponsorship language, character count, the process/procedure for submitting applications for county signage, and the uses for the signs (i.e., historical, cultural, event, archaeological, or all), as well as the placement/location of the signs, state markers vs county, and the missing marker for Fort San Francisco de Pupo and location for replacing the sign.

This Indenture, made this 19th day of April A. D. 1937, between F. W. Budington and his wife, Callie Budington, of the County of Clay and State of Florida, parties of the first part and The County Commissioners of Clay County, Florida, /whose permanent address is Clay County, Florida, of the County of Clay and State of Florida, party of the second part, Witnesseth, that the said parties of the first part, for and in consideration of the sum of One Dollar, to them in hand paid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and transferred, and by these presents do grant, bargain, sell and transfer unto the said party of the second part and its successors and assigns forever, all that certain parcel of land lying and being in the County of Clay, and State of Florida, more particularly described as follows: Being in the Town of Middleburg, Clay County, Florida, and described as: Beginning at the Northeast corner of Mrs. M. A. Chalker's properties and running North 28° 30' West, 162.5 feet for a point of beginning; thence running South 73° 35' West 200.0 feet, thence North 28° 30' West 150.0 feet; thence South 73° 35' East 200.0 feet; thence South 28° 30' East 150.0 feet to the point of beginning and being a part of Lot Two, Section Twelve, Township Five South, Range Twenty-four East. This property above described is to be used for the ground upon which a Canning Center and Recreation Hall are to be erected for the citizens of the Town of Middleburg, and for no other purpose. The property is not to be used for any school purposes whatsoever.

Budington, on a separate and private examination, taken and made by and before me, and separately and apart from her said husband, did acknowledge that she made herself a party to the said deed of Conveyance for the purpose of renouncing, relinquishing and conveying all her right, title and interest, whether of dower or of separate property, statutory or equitable, in and to the lands therein described, and that she executed said deed freely and voluntarily, and without any constraint, fear, apprehension or compulsion of or from her said husband. Proposed Location for Middleburg Civic Association / Museum Historic Marker

The red x in the photo below indicates the location where we would like the marker placed. It should be inline with the existing "time capsule" structure that is facing Palmetto Street at a slight angle.



HISTORIC MIDDLEBURG CIVIC ASSOCIATION AND MUSEUM

In 1935 Works Progress Administration (WPA) approved federal government funding for a Recreation Hall and a Canning Center to be erected in Middleburg for citizens of Clay County. By April 19, 1937, Mr. and Mrs. Frosard W. Budington deeded a parcel of land on Palmetto Street to the Clay County Commissioners for that purpose. By 1938, work on both structures was completed, and in November of that year the Middleburg Community Home was formed to oversee activities and maintain the Hall. In 1941 the name changed to the Middleburg Civic Association, with a charter and set of bylaws to promote worthy social and civic projects and organizations for the benefit of the Middleburg Community. The Canning Center was never used for canning, but served successively as a County Public Health Center, a Loan Closet for Medical Equipment and Supplies, a Clothes Closet, and a Food Bank. In 1989 the building became the home of the Middleburg Historical Museum. The Museum was reincorporated in 2020 as The Middleburg Museum, Inc., and continues its mission to educate, preserve, and promote the history of Middleburg with artifacts donated by local families and others.
