Fort 11: Language

FORT NUMBER 11, AN 1839-1840 SEMINOLE WAR OUTPOST

Midway through the Second Seminole War that was to last from 1835 to 1842, Zachary Taylor assumed command of the Army of Florida. While working to drive the Indians and their allies ever farther south, Taylor also aimed to protect the American settlers 'behind the lines' from further attacks by setting up a chain of forts across north-central Florida. Each post was established within a twenty-mile square laid out with bridle paths in every direction, and staffed by a small contingent of troops provided with gardening supplies. One such outpost was Fort No. 11, named for the military square on which it was sited, in present-day Keystone Heights. It was established in March 1839 by Company H of the US 2nd Infantry, commanded by Lieutenant H. W. Wessells, while General Taylor was personally present. It was situated just east of spring-fed Keystone Lake (then known as Soldiers Pond), southwest of present-day Lake Geneva, and strategically placed to intercept Indian war parties passing through in the nearby Itoniah Scrub. Forts of this type had a rectangular palisade, typically reinforced by two blockhouses set in opposite corners. Inside there would be stables and storehouses, along with officers' quarters. The rest of the troops might camp outside the south palisade. Its small garrison periodically hosted mounted patrols of the 2nd Dragoons sent from Fort Heileman on Black Creek. An outbreak of disease among the regular troops in November 1839 caused General Taylor to temporarily replace them with a company of Florida Volunteers. But when the next Army commander, W.K. Armistead, shifted his priority to sending out larger units to pursue the Indians in the field, most of Taylor's "squares" had to be evacuated. The last post return for Fort No. 11 was dated June 1840. Eventually this war of attrition brought about the removal of most remaining Florida Indians and their Black allies. In 1842 William J. Worth, the last commander of the Army of Florida, declared the conflict over. He authorized nine white families and their ten Blacks to occupy the abandoned post as a base for settling homesteads and monitoring traffic through the Itoniah Scrub. Soon afterward Fort 11, like so many other wooden Seminole War outposts, faded from history and from memory.
