Middleburg Colored School Update:

There was no update due to Dr. Maureen Jung's absence.

Fort 11 Update:

Billy Gould addressed the Board to provide details and information regarding the update for Fort 11. There was some insight given by a local expert, and a draft of the language was made and provided for review.

There were comments, questions, and discussions regarding additional information and material found and research done, the material provided for review, two-sided marker vs. one, limitations for text, attendance by Tom Parham at the subcommittee meeting, request to visit other properties, Google Earth - historical view, location, and timeframe for the existence of Fort 11, searching for artifacts and how to move forward.

Keystone Heights Update:

Deirdre Murphy addressed the Board to provide details and information regarding the update for Keystone Heights. See Attachment A.

Comments, questions, and discussions were had regarding the text for the marker and the timeline and information needed for the placement of the marker.

St. Mary's Episcopal Church:

Randy Harris spoke about approaching the Commanding Officer at Camp Blanding regarding the German prisoner-war camp information.

There was a conversation regarding other ways to get information about POW camps in the area.

Vice-Chairman Deirdre Murphy spoke about the 2025 Centennial in Keystone Heights and the active Facebook page. An interior tour of homes is also scheduled in December to kick off the Centennial. Vice-Chairman Murphy mentioned the proposed Museum for Keystone Heights that was not approved mostly because of budget constraints. However, there was a new proposal for a pop-up museum to be held in the Pavilion for a weekend. It would be in conjunction with a Chautauqua event. Vice-Chairman Murphy spoke about the plans for that event in 2025. Vice-Chairman Murphy spoke about the spectacular Oak Tree next to the library in Keystone Heights and the possibilities of having it preserved and a marker placed.

Bella Franco noted that this was her last meeting due to relocating to St. Johns County.

The Board wished her well in her move and thanked Ms. Franco for her service.

Attachment "A" Keystone Heights Marker Update

Historic Marker

for The City of Keystone Heights

Keystone Heights, Florida was established in 1925 and evolved from a vision of creating a resort destination. The boom of the 1920s attracted John J. Lawrence of Pennsylvania to establish the Lawrence Development Company. The company purchased thousands of acres of land and named the new town, Keystone Heights in reference of Pennsylvania, "The Keystone State". Many of the early buildings had signs or symbols in the shape of a keystone, still seen on several of the historic buildings. After platting the streets in 1922, civil engineer, C. Ray Lawrence organized in an extensive promotional campaign for the company and the first settlers set about building modest homes. Lawrence also wanted a suitable place for perspective land purchasers to stay. The company built the three-story Keystone Inn on a site overlooking Lake Geneva. The Keystone Inn opened on January 1, 1924 and became the hub of social activities. The Pavilion at Keystone Beach was erected shortly after and was used for dances, boat rides, for the use of locals and guests of the hotel.

Dr. George Meade, was selected as the President of the Winter Chautauqua in 1926–1927 and chose the young town as its location. The National Chautauqua Institute event featured various programs including banquets, lectures, classes and musical programs held at the Keystone Inn and at an outdoor site is still called Chautauqua Circle.

Keystone Heights was incorporated in 1925. Originally intended as a winter resort, Keystone Heights became a retirement community by the 1930s and a summer playground in the 1940s and 1950s. In 1939 in anticipation of military involvement in World War II, two military installations were established in the county. A large training base for the US Army, Camp Blanding was built. The Keystone Inn was popular with the wives of servicemen and airman training near town. In 1954 the Keystone Inn caught fire and was badly damaged. It was demolished and the site turned into the Keystone Heights Nature Park.

Keystone Heights a thriving community has kept its intrinsic charm and will celebrate its Centennial in 2025.

Attachment "B" St. Mary's Episcopal Church Update

ST MARY'S EPISCOPAL CHURCH AND PARISH HALL

The revival of the national economy and the arrival of prosperous northern winter visitors seeking the 'healing waters' of Green Cove Springs enabled Episcopal Bishop John Freeman Young to commission the erection of St Mary's Episcopal Church in 1878. The Thaddeus Davids family donated its riverfront location, close to the town's leading hotels. Among its features were New York manufactured stained-glass windows, designed to allow ventilation in warm weather. The church's 'Carpenter Gothic' style – a wooden version of medieval English stone churches – is typical of the Episcopal missions prescribed by Bishop Young and his superiors for Florida and the American Southeast. The sanctuary held its first service in March 1879.

The adjoining Parish Hall, formerly an Army chapel at Camp Blanding, was purchased from the military base and moved here in 1948 by the subscription of 200 local residents and businesses. Its interior arches of glued laminated timbers spared the metal hardware needed for the production of weaponry during the Second World War. The central structure remains unchanged and serves as a vital part of the church and community. In 2002 it was added to the church's 1978 National Register designation.



A Brief History of the **Town of Penney Farms**

Long before Penney Farms there was a settlement called Long Branch, Florida. Dowling Lumber and Florida Farms and Industries provided employment to the sparsely populated community. Then the Florida Land Boom directed the nation's attention to Florida and in 1925, the department store pioneer J. C. Penney arrived. He purchased 120,000 acres in Long Branch as well as property including a saw mill and a hotel in Green Cove Springs hoping to develop a self sustaining farming community with offices in the nearby town. Bad weather, the real estate decline and the stock market crash pressed Penney to slow, but not squelch his idea for this farming community. As things turned out, a sixty acre

site for his Memorial Home Community, now Penney Retirement Community, survived and is part of the Town of Penney Farms. As the population grew it sported a school, church, hotel, gas station, store, jail, fire station, golf course, air field and swimming pool. Today, there is Penney Retirement Community, New Hope Community, an auto repair business, private homes, Town Hall, a Historical Museum, a beautiful passive park and lovely

section of the Florida Scenic Highway.

The Historical Society of Penney Farms was established in 2004 and, thanks to support from local and county governments, the organization moved into the renovated space of the former Penney Farms Fire Station in 2022. This move created a venue to hold meetings and events as well as display material of historical value that had been collected and preserved. The mission of the Historical Society is to educate the community about its rich and dynamic history, and maintain the museum as a repository for archival materials.




